# Weathering the storm

Summer is on our doorstep and like many of you, I'm looking forward to more opportunities to be outdoors and enjoy warmer weather. Summertime brings many of my favorite activities like cooking out with family and friends, time spent working in the garden and simply slowing down a bit to enjoy life.

Unfortunately, summer can also create the perfect conditions for severe weather. As the warmer days of summer approach, it's crucial to prepare for the possibility of severe storms. While we often enjoy summer for its sunny days and outdoor activities, this season also brings the risk of thunderstorms, heavy rain and high winds. Being ready for these events can protect your home and keep your family safe.

Rayle EMC crews are always prepared and standing by to respond should power outages occur in our area. When severe storms cause power disruptions, our line crews take all necessary precautions before they get to work on any downed lines.

I would encourage you to also practice safety and preparedness to protect your family during storms and outages. You can also play a role in keeping our linemen safe. When you see utility vehicles on the side of the road, move over a lane, if possible. If that's not an option, slow down below the speed limit and be prepared to stop.

The Federal Emergency Management Agency recommends the items below as a starting point for storm and disaster preparedness, but you can visit *www.ready.gov* for additional resources.

- Stock your pantry with a three-day supply of nonperishable food, including canned goods, energy bars, peanut butter, powdered milk, instant coffee, water and other essentials (i.e., diapers and toiletries).
- Confirm that you have adequate sanitation and hygiene supplies including towelettes, soap and hand sanitizer.
- Ensure your first-aid kit is stocked with pain relievers, bandages and other medical essentials, and make sure your prescriptions are current.
- Set aside basic household items you will need, including flashlights, batteries, a manual can opener and a portable, battery-powered radio or TV.
- Organize emergency supplies in one location so they are easily accessible.

In the event of a prolonged power outage, turn off major appliances, TVs, computers and other sensitive electronics. This will help avert damage from potential power surges and will also help prevent overloading circuits during power restoration. That said, do leave one light on so you will know when power is restored.

If you plan to use a portable generator, make sure it's rated to handle the amount of power you will need, and always review

the manufacturer's instructions to safely operate it.

Severe storms can occasionally bring down power lines. If you see a downed line, always assume it's energized and never approach it. If flooding occurs, never walk through areas where power lines could be submerged.

Advance planning for severe storms or other emergencies can reduce stress and anxiety caused by the weather event and lessen the impact of the storm's effects.

Listen to local news or a NOAA Weather Radio for storm and emergency information, and sign up for NOAA emergency alerts and warnings. Check Rayle EMC's website and Facebook page for the latest power restoration updates. If you experience an outage, please don't report it on Facebook. Call our outage reporting number at 1(844) 744-7849. You also can text your outage by texting #OUT to 85700, or you can call one of our local numbers. These are the fastest ways to let us know if your power is out.

If you experience a power outage after severe weather, it's likely many other customers are out too. When there are widespread power outages, Rayle EMC follows a restoration process that focuses on repairs that will return power to the greatest number of customers as safely, quickly and efficiently as possible. Emphasis is placed on vital public health and safety facilities such as hospitals, law enforcement, fire departments, water treatment facilities and pumping stations.

We do our best to avoid power disruptions, but they are inevitable from time to time. If the lights go out, know that your co-op team is working as quickly and safely as possible to restore power. Our member services representatives are taking your calls, engineers and field staff are surveying damage, our vegetation management team is clearing hazards, dispatchers are organizing crews and communicators are keeping everyone informed of progress or potential dangers. When your power goes out, we all work together to get you back to normal.



### INDEPENDENT AUDITOR'S REPORT

The Board of Directors Rayle Electric Membership Corporation

### Opinion

We have audited the financial statements of **Rayle Electric Membership Corporation**, which comprise the balance sheets as of September 30, 2024 and 2023, and the related statements of operations and comprehensive income, changes in members' equity, and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Rayle Electric Membership Corporation as of September 30, 2024 and 2023 and the results of its operations and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS) and the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rayle Electric Membership Corporation and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rayle Electric Membership Corporation's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and *Government Auditing Standards* will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS and Government Auditing Standards, we:

- · Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatements of the financial statements, whether due to
  fraud or error, and design and perform audit procedures responsive to those risks. Such procedures
  include examining, on a test basis, evidence regarding the amounts and disclosures in the financial
  statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Rayle Electric Membership Corporation's internal control.   financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Other Reporting Required by Government Auditing Standards

In accordance with Government Auditing Standards, we have also issued our report dated Desember 19, 2024 on our consideration of Rayle Electric Membership Corporation's internal control; compliance with provisions of laws, regulations, contracts and grant agreements; and instances of fraud. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of Rayle Electric Membership Corporation's internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards in considering Rayle Electric Membership Corporation's internal control over financial reporting and compliance.



cause of flickering lights and extended power outages, especially when combined with summer storms. To reduce the chance of outages, Rayle EMC works daily to keep nearly 4,000 miles of distribution lines clear of trees and other overgrown foliage. Currently, our contract right of way crews, Townsend/ McAllister and Georgia Right of Way are working in western Wilkes County and western Lincoln County. We will soon have another Townsend crew begin work in the Robinson community in Greene and Taliferro counties.

As I'm sure all of you remember, Hurricane Helene made landfall in Florida's Big Bend region on Sept. 26, 2024, as a Category 4 storm. Helene then moved quickly inland through Georgia. Hurricane Helene caused significant damage throughout Rayle EMC's service territory. Helene entered Rayle as a tropical storm with sustained winds of 45 mph and gusts as high as 70 mph. Transmission lines were damaged throughout the state, some affecting seven of our 23 substations, with the outages at these substations lasting three days or more. The outages at the onset numbered approximately 12,000 meters out of approximately 20,000 meters.

Thanks to your Rayle EMC employees, neighboring EMCs and contract crews, we were able to repair and restore the damage, including more than 300 broken poles, in a remarkable time frame. A special thanks must go to our entire community for the support and help we received during this unprecedented storm.

I hope we do not experience severe storms over the summer months, and I especially hope we never experience another hurricane like Helene, but we can never predict Mother Nature's plans. At Rayle EMC, crews are prepped and ready to roll out, because storm preparedness is always our best defense.
